**The following items of business will be discussed, considered, and potentially acted upon by the Board of Directors of the Central Texas Groundwater Conservation District (CTGCD): (see footnote 1)**

**PUBLIC HEARING ON PROPOSED DISTRICT RULES**

**Call hearing to order and establish a quorum.**

1. Open public hearing on Proposed District Rules and presentation of brief overview of Rules. The proposed rules: require the registration of water wells with the CTGCD; require persons to obtain permit(s) or permit amendments from the CTGCD before drilling, operating, completing, equipping, or altering certain wells; impose well spacing requirements between wells and from property lines; impose limits on the amount of water that can be produced from a well annually; grandfather the location and production of certain existing wells and give them preferential treatment over future wells, subject to certain restrictions; require owners of certain existing wells to establish proof of the maximum amount of water used historically in a calendar year; establish permitting procedures; establish penalties for violations of the rules, including civil monetary penalties not to exceed \$10,000 per day per violation; require certain well owners to obtain and install meters for their wells and report annual groundwater production amounts to the CTGCD; establish certain fees, including fees and other regulations for producing water from wells located in Burnet County and transporting the water for use outside of Burnet County; establish permitting and reporting requirements for the use of groundwater by rock quarries and other aggregate quarries; establish differing regulations for different aquifers or areas of Burnet County, including authorizing the establishment and enforcement of caps on the total amount of groundwater that may be produced annually from an aquifer or area; require the submission of certain reports and well logs to the CTGCD; authorize the inspection of wells by the CTGCD and the prohibition of open, uncovered, abandoned, or deteriorated wells; prohibit waste of groundwater; and provide for the regulation of water wells to prevent unreasonable affects on surrounding landowners..
2. Receive public comments on Proposed District Rules.
3. Discuss future consideration and/or action on Proposed District Rules.

4. Adjourn, recess, or continue rulemaking public hearing; written record may be left open for a limited time.

At any time during the meeting and in compliance with the Texas Open Meetings Act, Chapter 551, Government Code, Vernon's Texas Codes, Annotated, the Central Texas Groundwater Conservation District Board may meet in executive session on any of the above agenda items for consultation concerning attorney-client matters (~55 1.071); deliberation regarding real property (~55 1.072); deliberation regarding prospective gift (~55 1.073); personnel matters (~55 1.074); and deliberation regarding security devices (~551.076), Any subject discussed in executive secession may be subject to action during any open meeting.
2. Citizens who desire to address the Board on any matter may sign up to do so prior to the meeting. Public comments will be received during this portion of the meeting. Please limit comments to 3 minutes. No discussion or final action will be taken by the Board.
