General Manager Shell also reported that the District, along with three other Districts, had purchased the downhole camera that was budgeted for in the Fiscal Year 2014-2015 District Budget.

Wayne Brown asked Hydrologist Sodek if we had received the final isotope data on the Ellenburger Study and costs for a flow meter on Delaware Creek from the United States Geological Survey. Hydrologist Sodek reported that we have received the isotope data and that the data has been sent to the Texas Water Development Board and that we are still working on plans to monitor Delaware Creek.
