MINUTES OF May 18, 2020 BOARD MEETING CENTRAL TEXAS GROUNDWATER CONSERVATION DISTRICT

The Board of Directors of the Central Texas Groundwater Conservation District met in regular session on Monday, May 18, 2020 at 9:00 a.m. at the Texas Agrilife Extension Auditorium, 607 North Vandeveer Street, Burnet, TX 78611.

President Felps established a quorum through a roll call of Directors; declared a quorum present; and called the Meeting to order at 9:00 a.m.

President Felps then asked for public comment. There was no public comment.

President Felps then asked for consideration and/or action on the Minutes of the Regular Board Meeting held on February 21, 2020.

Kathy Griffis-Bailey moved to:

Approve the Minutes of the Regular Board Meeting held on February 21, 2020.

Second was by Ricky Bindseil.

Vote on the motion carried.

President Felps then asked for consideration and/or action on Expenditures for February, March and April 2020; Review of 2019-2020 Budget; Budget Line Item Adjustments and Quarterly Report on Investments. General Manager Sodek reported that the following line item adjustment was made within a budget category to the Fiscal Year 2019-2020 Budget.

Moved \$41.10 From Other Expenses - Insurance - Errors & Omissions To Expenses - Insurance - Public Officials Bond

Ricky Bindseil moved to:

Approve the Expenditures for February, March and April 2020.

Second was by Bill Luedecke.

Vote on the motion carried.

Public Funds Investment Officers, Mitchell Sodek and Donnita Coats, gave the Board a Quarterly Report on the Investment Position of the District for the quarter ending March 31, 2020 in accordance with Section IV of the Public Funds Investment Policy of the District.

President Felps then asked for consideration and/or action on a Request for Waiver of Late Payment & Penalties on Taxes - Kathleen & Stearns LaSeur.

Bill Luedecke moved to:

Deny the Request for Waiver of Late Payment & Penalties on Taxes - Kathleen & Stearns LaSeur. Second was by Ryan Rowney.

Vote on the motion carried.

President Felps then asked for consideration and/or action on Operating Permit Corix Utilities-Summit Springs Non Compliance. General Manager Sodek reviewed the history of the permit and the non-compliance issue with the permit involving the ownership of water rights associated with it. Corix Utilities self-reported the violation and Scott Ahlstrom with Corix Utilities addressed the Board to explain the circumstances that led them to the knowledge that they were not in compliance with the permit terms and the action being taken to obtain the water rights needed to become compliant. General Manager Sodek suggested that the Board hold a show cause hearing in June to allow the permit holder to appear before the Board and issue an Agreed Enforcement Order.

Kathy Griffis-Bailey moved to:

Proceed with notice of a Show Cause Hearing on the Corix Utilities-Summit Springs non-compliant Operating Permit.

Second was by Ricky Bindseil.

Vote on the motion carried.

President Felps then asked for consideration and/or action on Operating Permit Deer Springs Water Corporation Non Compliance. General Manager Sodek reviewed the history of the permit and the non-compliance issue with the permit involving metered water usage being above the permitted amount and the increasing trend in usage.

Kathy Griffis-Bailey moved to:

Proceed with notice of a Show Cause Hearing on the Deer Springs Water Corporation non-compliant Operating Permit.

Second was by Ryan Rowney.

Vote on the motion carried.

President Felps then asked for consideration and/or action on Operating Permit Theresa Schweiger-Thomas Ridge Ranch Non Compliance. General Manager Sodek reviewed the history of the well which is being used as a quasi-public water supply well but is not registered with TCEQ or permitted with the District.

Kathy Griffis-Bailey moved to:

Proceed with notice of a Show Cause Hearing on the Theresa Schweiger-Thomas Ridge Ranch non-compliant Operating Permit.

Second was by Ricky Bindseil.

Vote on the motion carried.

President Felps then asked for consideration and/or action on Selection of Architect from Request for Qualifications Responses. General Manager Sodek discussed the criteria for evaluation of the four firms that responded to the Request for Qualifications, presented his criteria evaluation and the Board discussed their criteria evaluations.

Bill Felps moved to:

Rank the following four firms as most qualified to perform the required services (With 1 being the most qualified) and to proceed with using Kissling Architecture, Inc. to work with the District to develop a conceptual office layout and cost estimates for a proposed District Office:

With no significant recharge so far this season there may be a need to change the Drought Stage in the future but he recommended that there is no need to change the current Drought Stage 1 – Near Normal at this time.
